Format for Note (Full):

Note number. Author First Name Last Name, "Article Title," *Name of Magazine*, Date of Pub., Page(s) Cited.

Format for Note (Short form):

Note number. Author Last name, Page(s) Cited.

Lemonick, Michael D. "Too Few Fish in the Sea." *Time*, April 4, 1994, 70-71.

Sample Note (Full):

Author Last Name, First Name. "Article Title." *Name of Journal* Volume Number, Issue Number (Date of Pub.): Page Numbers.

Format for Note (Full):

Note number. Author First Name Last Name, "Article Title," *Name of Journal* Volume Number, Issue Number (Date of Pub.): Page(s) Cited.

Format for Note (Short form):

Note number. Author Last name, Page(s) Cited.

Sample Note (Full):

Format for Note (Short form):

Note number. Author Last name.

Arnold, David. "Cutting a Deal for Nature." *Boston Globe*, December 26, 2002.

Sample Note (Full):

Format for Note (Short form--no author):

Note number. "Article Title" (shortened).
