Note number. *Title of Law*, Public Law Number, Section Number, *U. S. Statutes at Large* Volume Number (Year of Law), Page Number On Which Act Begins, Page(s) Cited.

Format for Note (Short form):

Note number. *Title of Law*, Page(s) Cited.
